HIGHLIGHTS

Greater Omaha's economy continued to perform well in August 2024. The unemployment rate rose from 2.6% in August 2023 to 3.1% in August 2024, which is slightly higher than Nebraska's (2.9%) and below the U.S. (4.4%). Greater Omaha has seen an increase of 13,000 net jobs compared to August 2023. The industries that have seen the largest increase are Education and Health Services (8.0%), Leisure and Hospitality (3.7%), Manufacturing (3.3%), and Information (2.9%). Finally, Eppley saw an increase in passenger enplanements compared to August 2023.

Nationally, the U.S. Bureau of Economic Analysis released GDP by state for Q2 2024. GDP measures the goods and services produced in a state and is the most comprehensive measure of economic activity. GDP increased in almost every state, with the U.S. growth rate at 3.0%. Nebraska experienced an increase at 5.3%, while Iowa experienced an increase at 1.6% over their Q1 2024 GDP.

The Nebraska Department of Labor analyzes wages, educational requirements and occupation projections to put together a report on H3 occupations. H3 occupations are considered to be High Wage, High Skill and High Demand. The top 3 H3 occupations for the Omaha area are Heavy and Tractor-Trailer Truck Drivers, General and Operations Managers, and Registered Nurses.
